The hotel was acquired by Stellar Heliskiing in 2022. Today's Kaslo Hotel offers modern amenities: spacious rooms with private balconies offering lake and mountain-views, contemporary comforts, and a restaurant/bar known as "The Waypoint Restaurant and Bar".

Under the terms of the transition, Stellar Heliskiing and the Kaslo Hotel operational teams, crews and guest-facing staff are expected to remain in place, ensuring continuity for returning guests and visitors.
